Councillor Pearson advised the Committee that he had raised an enquiry with the Planning Department at Cannock Chase Council about planning consultations being sent on occasion to the wrong parishes. He said he understood the issue was now resolved.

Councillor Cotton advised the Committee that he had received advice from the Planning Department that installation of a small shed on the recreation ground at Etching Hill would require planning permission. The advice appeared inconsistent with previous advice that stables on sleds could be installed under permitted development as long as the structure was not fixed to the ground. The proposed shed would sit on a base of paving slabs.

Councillor Pearson and Councillor Sutherland offered to make further enquiries to Planning Officers in this regard.
